HB1075/SB 1772. Brad Johnson reported that the two Florida Bills, which would dissolve all SWCD's had died in committee on 8 March 2024.

<u>Annual Report.</u> The draft 2023 Annual report was passed out by Dr. Linda Johnson and reviewed by the board. David Clark made a motion to accept the Annual Report after highlighted changes were made, which was 2<sup>nd</sup> by Melody Irwin and accepted by the board.

<u>Five-year YRSWCD Business Plan.</u> A draft 2023-2028 YRSWCD Business Plan was passed out by Brad Johnson. Mr. Johnson requested the Board to review the plan Section II (p. 32 – 40). Section II covers Soil and Water Related Resources Concerns. Section I, is the Introduction and describes agriculture, population and physical characteristics of Okaloosa County. Mr. Johnson requested that Board send any

comments to Tara Llewellyn. Mr. Johnson will consolidate comments and present the updated final document at the next Board meeting.

#### **New Business**
